3 Minutes of Last Meeting (24 Dec 2013)

The A Division had 6 teams (including 2 Manchester teams), B Division had 8 Teams, C Division had 7 teams with the North East not playing any C Team matches. The introduction of junior matches (U25 in principle) had not happened but it was hoped the County representatives would report back to their Executives and work towards getting at least one junior match organised. The non-allocation of Masterpoints for final rankings was in line with the original Bavin Masterpoint correspondence, but there was a feeling that there should be some bonus for this.

4 Matters arising from 2014 and NBL League Report

- (a) Manchester won the A Division, Lancashire won the B Division and Yorkshire SE won the C Division.
- (b) National County Final will be on Sun 28 June 2015 at Coventry (potential clash with Presidents Cup?).
- (c) An £80 cancellation fee was still outstanding from the North East for the Blackburn fixture called off at 5 days notice. Should the North East not pay this, it would regrettably have to be written off (i.e. paid to Blackburn BC from NBL funds). It was decided for the future that Counties only forfeit food costs if less than 4 days notice.
- (d) There were potential new venues of Merseyside BC, Brierfield, Bolton BC, Deva BC and following adverse comments at the meeting on the Manchester venue, Mr Byrne would convey suggestions for improvement back to the proprietor at Manchester BC.

5 Treasurers Report

Stuart Davies presented the Accounts for 2014 which showed assets of about £176 (after the £80 write off and meeting expenses settled). Stuart presented a budget plan for the 2015 season with similar expenses to the 2014 season other than the duplication of 4 sets of boards at £35 per match per pool (rather than £25 for 2 sets). This was agreed and it was noted that head to head matches could thus be run more easily.
