3 Minutes of Last Meeting (24 Oct 2014)

The A Division had 6 teams (with two Manchester teams), B Division had 8 Teams, C Division had 7 teams. The non-allocation of Masterpoints for final rankings was again confirmed.

4 Matters arising from 2014 and NBL League Report

- (a) The same teams as last year Manchester [A], Lancashire [B], Yorkshire SE [C] won the Divisions.
- (b) The new venues of Brierfield and Bolton BC had been fine. Manchester BC had improved.
- (c) The earlier start of 12:30 and TD time limits had worked well and would continue.

5 Treasurers Report

Stuart Davies presented the Accounts for 2014 which showed a loss of around £200 balanced against assets of about £176 from last year. The main reason was increased TD travel expense, two £50 payments for Leeds BC. However, NBL review meeting expenses were reduced. It was mentioned that club venues should supply according to budget eg wine at Keighley was not necessary. Stuart presented a budget plan for the 2015 season and after discussion,the following charges were agreed which should produce a small profit.

County Fee £75 per team. Money to be sent to Stuart by April 1st 2016

Table Money £12:50 per player Catering/Venue £10 per head.

TD Fee £75 (The £100 for running two matches was discontinued)

Assistant TD Fee Discontinued TD Travel 30p per mile

Duplimate £35 per match per pool (4 copies including Hand Records)

WebMaster £100

Scoring Support Discontinued as future support from EBU

6 Review of 2015

Mike Rothwell remarked how well the NBL season had gone. Butlers should be XImps on the WebPage. It was noted, TDs should be there 1½-2 hours before start. Any problems had been at the A Division level - Manchester flagged problems running the second A team with their priority winning the B division. Lancashire reported limited A Team resources due to holidays and refusal of participation by certain players. Also Cumbria, Westmorland, N Wales, N East did not play in the A Division and they were invited to put a team there in future. The NBL Division standards Tolle, County, Club should be viewed as the County best players for the A Division, the next best players for B and Club Players for C. No one may play for two different Counties in same season. Yorkshires A Division approach of a ring-fenced A1 team, which included A2 team players when necessary was endorsed. (In extenuating circumstance, these constraints could be overridden and it was also allowable to field players without primary allegiance).
